RELEASE OF LIABILITY FOR MINOR PARTICIPANT

I (We), the undersigned parent(s) or legal guardian(s) of _____, a minor (the "Minor"), acknowledge that the Minor desires to attend and participate in basketball programs, practices, games, events and other activities (collectively, "Basketball Activities") provided, organized and/or sponsored by, on behalf of, or through Wintersburg Presbyterian Church of Garden Grove ("WPC") and, in consideration thereof, hereby voluntarily enters into this Release of Liability for Minor Participant (this "Release").

Acknowledgment of Risks. The undersigned fully understands: (i) basketball is a physically and emotionally demanding activity; (ii) in connection with the Minor's attendance or participation in any Basketball Activities, the Minor will be exposed to risks, dangers, conditions and environments, including, but not limited to, risks, dangers, conditions and environments that could result in bodily injury, emotional distress, illness, harm, paralysis and death to the Minor, damage to the Minor's property and/or economic losses; (iii) such risks, dangers, conditions and environments may be caused by the action, inaction or negligence of WPC and others; and (iv) no warranty, representation or guarantee of any kind, whether express or implied, has been made or will be made that the Minor's attendance and/or participation in any Basketball Activities will be free from such risks, dangers, conditions and/or environments.

Assumption of Risks and Release of Liability. With full knowledge of the risks, dangers, conditions and environments in connection with the Basketball Activities, the undersigned, on behalf of myself, my spouse (if any), and the Minor, and each of such person's respective heirs, successors, assigns, executors, trustees, legal representatives and administrators, hereby: (i) assumes and accepts all risks, dangers, conditions and environments in connection with the Basketball Activities and the Minor's attendance and participation in Basketball Activities, including, but not limited to, risks of bodily injuries, emotional distress, illnesses, harm, paralysis and death to the Minor, damages to the Minor's property and economic losses; and (ii) forever release, discharge, waive and hold harmless WPC, affiliates and affiliated organizations of WPC, and each of their respective members, elders, directors, officers, employees, personnel, volunteers, agents, representatives, contractors, sponsors, suppliers, vendors, lessees, lessors, owners of premises, other participants, coaches, referees and spectators, and each of their respective successors and assigns (collectively, the "Releasees") from any and all claims, liabilities, demands, losses, damages, losses, expenses (including reasonable attorneys' fees and costs), lawsuits, proceedings, actions, and causes of action of whatever kind or nature, whether in tort or contract, whether at law or in equity, whether known or unknown, whether now accrued or hereafter maturing (collectively, "Claims"), for any and all bodily injuries, emotional distress, illnesses, harm, paralysis and/or death to the Minor, damage to the Minor's property, and/or economic losses that in any way arises from, relates to, or is in connection with any Basketball Activities and/or the Minor's attendance and/or participation in any Basketball Activities, whether caused by or resulting from, in whole or in part, by any action, inaction or negligence of any Releasees or any equipment, property and/or condition owned, maintained and/or operated by any Releasees.

Miscellaneous Provisions. This Release is a full and complete agreement with respect to the subject matter set forth herein and supersedes all prior agreements, statements, or understandings with respect thereto. No other documents, oral promises, or other information can be used to modify any terms of this Release without the prior express written consent of WPC. This Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that if any portion of this Release is held invalid or unenforceable, the balance of this Release shall continue in full legal force and effect to the fullest extent permitted by the laws of the State of California.

Knowing and Voluntary Execution. By signing this Release, I certify that (i) I am at least eighteen (18) years of age, (ii) I am either a parent or legal guardian with full legal rights relating to the Minor, (iii) I am competent and have the right to sign, deliver and perform this Release, and (iv) I have carefully read this Release, fully understand its contents, and sign it voluntarily.

AUTHORIZATION TO CONSENT TO TREATMENT OF MINOR

(I) (We), the undersigned parent(s) or legal guardian(s) of _____, a minor (the "Minor"), acknowledge that the Minor is or will be attending and participating in basketball programs, practices, games, events and other activities (collectively, "Basketball Activities") provided, organized and/or sponsored by, on behalf of, or through Wintersburg Presbyterian Church of Garden Grove ("WPC").

In connection with any Basketball Activities, the undersigned hereby authorizes WPC and each of its directors, officers, elders, employees, personnel, agents, and other representatives who are 18 years of age or older, each as agent(s) for the undersigned, to consent to: (i) any x-ray examinations, anesthetic, medical or surgical diagnosis or treatment, or hospital care which is deemed advisable by, and is to be rendered under the general or special supervision of, any physician and/or surgeon licensed under the provisions of the California Medical Practices Act; and/or (ii) any x-ray examinations, anesthetic, dental or surgical diagnosis or treatment, or hospital care which is deemed advisable by, and is to be rendered under the general or special supervision of, any dentist licensed under the provisions of the California Dental Practices Act. It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care to provide authority and power on the part of the aforesaid agent(s) to give specific consent to any and all such diagnosis, treatment or hospital care which aforementioned physician or dentist, in the exercise of his/her best judgment, may deem advisable. This authorization is given pursuant to the provisions of California Family Code section 6910.

The undersigned hereby authorizes any hospital, which has provided treatment to the above-named minor pursuant to the provisions of California Family Code section 6910, to surrender physical custody of such minor to any of the above said agent(s) upon the completion of treatment. This authorization is given pursuant to California Health and Safety Code section 1283.
